# Questions to answer:

- Please perform an assessment of the welfare of the dogs and cats at the shelter. Present and discuss positive and negative aspects for both dogs and cats.
- Provide recommendations to improve the welfare of the dogs (two recommendations) and cats (two recommendations) at the shelter, taking into consideration animal management, husbandry and facility design.
- Provide one long-term recommendation to optimize the sustainability of operating the shelter now and in the future.

# Background

- Open intake Municipal shelter
- ~800 dogs admitted each year
- ~1500 cats admitted each year
- Shelter operates at 50-100% capacity year round
- 93% dog live release
- 55% cat live release
- Average Length of Stay: 60 days (cats), 40 days (dogs)

# Staffing

- 1 part time veterinarian on site once a week
- 1 full time DVM position currently being advertised
- 3 full time veterinary assistants, one position is empty & being advertised
- 8 full time caretakers, assigned to specific areas in shelter
  - 60% turnover rate/year
- 20 volunteers who walk dogs and create enrichment items for cats
  - Volunteer time: 1-2 hours/week

# Intake and Holding procedures

- 5-day required legal stray hold
- Housed in holding area to complete following intake procedure:
  - Health exam performed by veterinarian only
  - Scan for microchip
  - Identification, weight, sex, age estimate
  - Receive medical care if necessary
- Average time in holding area prior to moving to adoption floor:
  - 21 days (cats) 14 days (dogs)

## Environmental enrichment

#### **Dogs**

- Current enrichment opportunities:
  - Toys/blankets
  - Leash walks
  - Food treats
  - Volunteer interactions including play, petting and grooming
  - Raised bed
- Reactive dogs on adoption floor:
  20%

#### Cats

- Current enrichment opportunities:
  - Toys
  - Music
  - Cage furnishings include:
    - Litter pan
    - Towel/bed
    - Hide box
    - Elevated area for resting
- Cats hiding on adoption floors: 25%

## Preventative care at intake

#### **Dogs**

- Pyrantel de-wormer, topical flea and tick preventative and canine heartworm test
- Vaccinations: MLV DHPP, Rabies, Intra-nasal MLV: Bordetella, CPIV, Adenovirus
- Heartworm positive: 10%
  - Review protocol for treatment

#### Cats

- Pyrantel de-wormer, topical flea and tick preventative, and single dose ponazuril for kittens < 4 months
- Vaccinations: MLV FVRCP, Rabies
- Feline upper respiratory infection # 1 medical issue at the shelter followed by kitten diarrhea

### Treatment room

- Sick dogs and cats are housed in isolation located next to treatment room.
- Isolation has a separate feeding station, cleaning supplies and laundry area.
  - Three isolation rooms for cats
    - Cats are often treated for URI in cat holding due to lack of isolation space for sick cats
  - Three isolation rooms for dogs each with 3 double sided kennels
  - Isolation area has separate ventilation with 100% fresh air exchange
